Estimation criteria of the participants' bids:

- reports, prepared in INTERPIPE, on rejection of commodities & materials/works due to quality reasons, which have influenced on quality and prime cost of final products or sales of INTERPIPE company, as well as a failure to submit a set of support documentation cause invalidity of participant's offer in future;
- an unsettled lawsuit on one type of commodities & materials /works cause invalidity of participant's offer in future;
- delays of delivery time, which caused the stoppage of the technological process or failure of repair, reduce score of the participant in future bargain;
- reduced price including additional costs and value of money in case of deferment/prepayment is one of main evaluation criteria for participants' offers;
- compliance with delivery terms according to the conditions required by the tender increases score of a participant when estimating his/her offer;
- financial sustainability of a supplier is taken into account when estimating participant's offer;
- availability of the certified quality system increases the score of tender participant;
- availability of own qualified trained personnel to perform / provide services / works (provided that support documents are available) increases the score of tender participant;
- work experience in a relevant field (provided that reference lists are available) increases the score of tender participant;
- a conclusion of experts of technical departments on a possibility to apply commodities & materials /works/services on the plant assets. If there is no expert conclusion, the participant's offer is considered as not valid;
- a warranty period on supplied commodities & materials /works, with other conditions being equal, gives an advantage to the bidder;
- when estimating participant's offers, it is considered how many years the participant has been present on the market within the given subject.

At supplies of goods (works, services) under a contract, concluded at the end of the tender, a supplier of goods (works, services) guarantees that in supply chain to the manufacturer there are no goods (works, services) of suppliers, who (or whom it can concern):

1. Do not declare the tax liabilities.
2. Are declared to be bankrupt within the legally established order.
3. Terminated (liquidated, closed) or against whom a case was filed regarding termination (liquidation) or decision on termination (liquidation, closure) was taken.
4. Location absence record was done in the unified state register.
5. Certificate of VAT registration was canceled.

Tender participants, who are affiliated persons, do not have the right to submit bids for the same lot of a particular tender. The Participant is responsible for the compliance with this requirement.

ATTENTION:

- The organizer of the tender has the right to extend bidding or to consider bidding as failed (unsatisfactory price level; less than two participants took part in bidding; a bid was submitted not properly etc.)
- Right to take part in rebidding is given only to those Participants of the tender, who made one of the best bids in electronic bidding (on the web-site of INTERPIPE Company).
- This notification is aimed to inform the participants and is not the ground for any commitments to be imposed. The significant terms of the deal according to bid submitted will be specified in the contract.
